Reserves Management & Auditability – Critical Requirements in Today's Oil & Gas Industry

The April Monthly Petroleum Technology Forum meets Tuesday April 10, 2007 at the Long Beach Petroleum Club. SPE Distinguished Lecturer Tony Harrison of Santos Ltd. will present "Reserves Management & Auditability – Critical Requirements in Today's Oil & Gas Industry." Abstract:

In recent years, petroleum reserves and the technical and commercial support underlying them, have become a hot topic of discussion in the investment community and the media. Senior oil company executives, board members and investors alike have become sensitive to the requirements for reserves booking and reporting. Reserves, whether they be Proved, Probable or Possible, are just one part of an oil companies total portfolio that also includes exploration potential and sub-commercial resources. All of these need to be captured and tracked in order to maximize the total portfolio, and ensure accurate and auditable reserves and resource reporting.

The SPE/WPC/AAPG reserves and resource classification system provides an excellent framework for capturing and tracking the total resource. This, combined with a clearly defined reserves process linked into, and an integral part of, the engineering and geoscience workflow, will provide assurance to all stakeholders that reserves are under control. Discussion will focus on the need for a reserves system that captures the total resource portfolio, the critical decision points within that system (focal points for corporate governance) and a process that provides quality control and an audit trail to ensure reporting requirements are met.

Biography:

Tony Harrison has spent nearly 30 years in the oil and gas industry. Graduating in geology and biochemistry at Oxford in the United Kingdom, Tony spent a number of years traveling the world as a consultant geologist before settling down in Australia with Santos Ltd. In more than 20 years with Santos, Tony has enjoyed a number of technical and supervisory roles initially in the geoscience area and then in reservoir engineering. Tony has held his current position of Reserves Manager for around 5 years. In 2004 Tony became a member of the world-wide SPE Oil & Gas Reserves Committee. Tony is an accomplished speaker and in the last couple of years alone, has presented at international conferences in Paris, London, Houston, Tunis and Perth.

Forum Report for March 2007

Forum Report for March 13, 2007

Dr. David Lumley, founder of 4th Wave Imaging, Inc. presented an excellent discussion of the application of time-lapse "4D" seismic technology to improved monitoring of reservoir depletion.

Multiple examples were provided showing movement of gas-water and oil-water contacts of North Sea fields depleting over time. Also shown were areas of the fields that were unsupported by pressure maintenance and areas where sweep could clearly be seen. When it works, bypassed oil can be seen, the movement of injection fronts and flow across faults can be monitored and infill well locations can be identified.

Dr. Lumley has developed a combined compressibility contrast analysis that can be used to screen reservoir candidates. His rule of thumb is that an overall contrast of 5% or greater is needed for successful analysis.

Since detailed seismic imaging can show fluid saturations and contacts where there is good compressibility contrast in the reservoir fluids and in higher porosity (>15%) and softer rocks, it would seem that many of the reservoirs in the LA Basin could be good candidates for at least a "snapshot in time" analysis of saturations. Such a look would require repossessing of existing good quality seismic data and ideally comparing the new analysis with reservoir model results.


LASPE Crude Price Challenge

Crude Price Contest Update

Thanks to all who participated in the contest. The contest closed at 11:59 PM on Valentine's Day and the winners won't be known until the May 1, 2007 price for 17° Wilmington crude is posted. The graph below shows the range of prices forecast by entrants and the price as of March 29, 2007. Prices climbed from a low of \$40.15 on January 18, 2007 to \$56.40 after an early March free-fall. Who knows what will happen over the next 33 days? Winners will be announced at the May 8, 2007 Forum presentation of California and World Pricing by Barry Evans and Tom Walker.

There were a total of 46 entries. Crude price estimates ranged from a low of \$34.99/bbl to a high of \$65.00/bbl. The average estimate was \$51.51/bbl. Closest estimate wins with earliest submittal the tiebreaker, if necessary.

First prize is a \$25.00 Trader Joe gift certificate that grows to \$50.00 if the winner is present at the May 8th Forum and grows even further to \$75.00 if the winner can produce their receipt from the January 8th Petroleum Technology Forum. Second prize is also a \$25.00 Trader Joe gift certificate, but with no enhancements.



2007 – 2008 Scholarships Still Available

The Los Angeles Basin of the Society of Petroleum Engineers wants to remind you **that time is running out to apply for scholarships for the 2007/2008 school year**. Students who are classified as undergraduates and graduate students at the beginning of the 2007 fall semester may be eligible for these scholarships. There are four types of scholarships available through the section:

- Mei Chang Memorial Scholarship: \$500 awards are available for high school graduates entering college in the fall of their graduating year. This scholarship is a tribute to Ms. Mei Chang, a Sr. Research Scientist with Chevron. She is remembered for her steady contributions to LASPE and for tutoring science and math high school students. The awards are available to children, grandchildren and siblings of LASPE members.
- Bruce Davis Memorial Scholarship: \$1,000 award is available for a USC student pursuing graduate studies in petroleum related fields, chemical engineering and chemistry. Dr. Davis, a 26-year employee of Chevron, considered himself an experimental chemist and wished to encourage students with science backgrounds to pursue a future career in the Petroleum Industry.
- Undergraduate Scholarships: \$500 scholarships are available for undergraduate college students pursuing petroleum engineering or geology, chemical, civil, mechanical, environmental or related engineering curriculums.
- Graduate Scholarships: \$1,000 scholarships are available for college graduate students pursuing studies or conducting research in energy and petroleum related subjects.

In addition to the above scholarships available through the section, the SPE Foundation annually awards the Gus Archie Memorial Scholarship, a four-year, \$5,000 annual grant to the outstanding college freshman pursuing an undergraduate degree in petroleum engineering.
