12. Goals

Outline goals established at beginning of year and report progress in meeting both long- and short-term goals.

Long-Term Goals:

1. Continue and strengthen the Section's continuing education program. Strive to offer at least three short courses per year. Due to extremely high activity in the industry, it has been very difficult to find available consultants to present any classes. However, we have a class scheduled for June 7 and it will be mentioned in next years report.
2. Maintain a 90% membership renewal rate. Due to Oxy in Long Beach expanding their staff with many young graduates, we have been able to expand membership in our section a little.

3. Look for creative ways to get members—especially younger ones—actively involved in Section activities. Our Vice Chairperson is leading a effort to hold two yearly “Young Professionals Socials”. The first is scheduled for June 7 and will be reported next year.
4. Maintain active liaison with other engineering and earth science societies.
5. Maintain and improve our yearly golf tournament fundraiser.

Short-Term Goals:

1. Improve member attendance at technology transfer functions. New programs are in the works, which should improve attendance.
2. Attract new faces for board and chair positions. Our nominations chairperson is actively recruiting potential members.
3. Survey members to determine what additional programs they expect from the Section.
4. Directly contact local companies and individuals for cash donations. Succeeded in receiving \$2000 in cash donations.

13. Constraints

List unusual constraints of the section in (1) membership development, (2) technical/educational activities, (3) scholarship activities, and/or (4) financial activities.

1) Membership development is constrained by declining LA Basin activity as compared to other oil producing areas. However, high oil prices have resulted in a net influx of new members into the area this past year.

2) The very high oil prices puts a strain on practicing engineers and related employees to have the free time to volunteer for SPE activities. Our section is dominated by smaller oil companies who have a strong focus on the bottom line and are not able or willing to encourage employees to detract from work duties to volunteer to help the SPE. Other than Occidental, there are no major oil operators in the LA Basin. Consequently, local SPE members working for independents will only attend meetings with specific topics of interest. Attendance at Forums contains a large contingent of older or retired consulting engineers.

3) Scholarship activities are somewhat constrained by the lack of a Petroleum Engineering Bachelors program at local universities (University of Southern California and California State University at Long Beach), but both schools encourage investigation into petroleum careers. USC has a masters and doctorate programs in Petroleum Engineering.

4) There are currently no financial constraints.
